East Delhi Municipal Corporation runs Rajmata Vijayaraje Scindia Nursing School at Swami Dayanand Hospital, Delhi for female candidates only. The School imparts training in General Nursing & Midwifery course of 3 years duration & award “**Diploma in General nursing and Midwifery.**” The school is affiliated to Delhi Nursing Council & Indian Nursing Council.

### **SWAMI DAYANAND HOSPITAL:**

Swami Dayanand Hospital was established in the year 1963. It has bed strength of 370. Hospital provides health care services to the residents of Trans Yamuna area and eastern outskirts of the union territory around Delhi. This hospital has all the major medical specialties and is running 14 (fourteen) specialized clinics.

SDN Hospital has started **Rajmata Vijayaraje Scindia Nursing School** for Diploma in General Nursing & Midwifery (3 Years Course) with batch strength of 20 students per year since 1st August 2013.

### **Admission:**

Regular admission for Diploma in General Nursing and Midwifery Programme will commence from 22nd October 2020 for duration of 3 years. It is a residential training programme.

### **ELIGIBILITY CRITERIA FOR ADMISSION :**

1. The student must have passed in all the subjects of 10+2 (five subjects as per C.B.S.E policy)
2. **Age:** Minimum age for admission will be 17 years (as on 31st December 2020). The upper age limit is 35 years (as on 31st December 2020). There is no age bar for ANM/LHV.

➡ **CANDIDATE BORN AFTER 31<sup>ST</sup> DECEMBER 2003, NEED NOT TO APPLY.**

### **3. Minimum education eligibility criteria for admission to GNM:**

- The candidate must have secured pass mark in English and three elective/ core subjects (see Point No 5 for list of subjects) at 10+2 level or equivalent exam. She must **score 40% of the aggregate of three elective or core subject** as qualifying criteria.
- Candidates are also eligible from State Open School recognized by State Government and National Institute of Open School (NIOS) recognized by Central Government, however Science stream is preferable.
- 10+2 with English (passing marks) and must have obtained minimum of 40% marks in vocational ANM course from the school recognized by Indian Nursing Council.

- 10+2 with English (passing marks) and must have obtained minimum of 40% marks in vocational stream- Health care Science from a recognized CBSE board/State/Centre.
- Registered ANM with pass mark
- **5% of total marks are relaxed for SC/ST candidates.**

#### **4. Reservation for disabled candidate:**

5% Disability reservation is to be considered with a disability of locomotors to the tune of **40% to 50% of the lower extremity only**. Other eligibility criteria with regard to age and qualification will be same as prescribed above.

**Note: A committee will be formed consisting of medical officer authorized by medical board of state government and a nursing expert in the panel which may decide whether the candidates have the disability of locomotors of 40% to 50%.**

**Note: Reservation shall be applicable within the sanctioned number of the seats by INC and not above it.**

**6. Percentage calculation:** - The best three subjects (Core/ Elective) marks will be taken for calculating percentage excluding English. **The candidate must have pass marks in English.**

7. Candidate must be declared medically fit by the medical Board of the Swami Dayanand Hospital.

#### **NOTE:**

1. Those candidates who have completed A.N.M. Course (10+2 Vocational {revised after 2001}) from school recognized by I.N.C are eligible to apply and should furnish a certificate from school principal regarding recognition of school by I.N.C.
2. Candidate should attach a copy of 12th certificate as well as roll number issued by Principal.

- ❖ **It is important to note that the application of candidate can be rejected at any stage of the admission process for not fulfilling the eligibility criteria which is subject to change as per direction of Indian Nursing Council/Delhi Nursing Council.**

#### **PROCEDURE FOR APPLYING:**

A candidate seeking admission to the 3 years Diploma in General Nursing Midwifery Course must submit application online in the prescribed format available at <http://www.mcdonline.gov.in> (EDMC).

A candidate who has already done LHV/ANM course & is applying for GNM Course must fill qualification column first before filling the date of birth.

### **CRITERIA FOR REJECTION OF APPLICATION**

- a) The candidate's admission can be rejected if any discrepancy is noted in the application form in the age column as compared to the age calculated from the Date of Birth as mentioned in the Candidates 10th Certificate (If the age calculated is less even by a day it will lead to rejection of the Application). **THE CANDIDATES SHOULD FILL IN THEIR EXACT DATE OF BIRTH (AS GIVEN IN THE MATRICULATION CERTIFICATE ISSUED BY THE 10TH BOARD IN THE FOLLOWING FORMAT DD/MM/YYYY i.e. IF YOUR DATE OF BIRTH IS SAY 1<sup>st</sup> January 2014 SHOULD BE ENTERED AS 01/01/2014) IN THE REQUIRED COLUMN OF ONLINE APPLICATION FORM TO AVOID REJECTION**
- b) Marks obtained in subjects of 10+2, calculated to 1 decimal place would be taken for eligibility which even less by a fraction shall not be rounded off to the next whole number i.e. **If the candidates has obtained 39.9% in aggregate it would NOT be rounded off to 40%** (even though the candidate has qualified in the entrance test). Further, any error/ omission in the processing /verification of certificate /documents of the candidate or any other information coming to the notice of authorities of the School/Hospital/Institution, at a later stage will make the admission liable to be rejected.

- c) Incomplete application form will be rejected out rightly. No claim what so ever for admission will be entertained thereafter.
- d) Application submitted with provisional certificate issued earlier than six months will be rejected.
- e) Scanned passport size photograph & signature other than JPG/JPEG format and file size exceed 2mb each may not be uploaded on the website.
- f) Wrongly filled forms will be sole responsibility of candidate and their candidature may be cancelled at any stage of admission process.

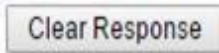

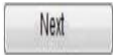

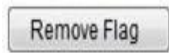

- The Marked for Review status for a question simply indicates that you would like to look at that question again. If a question is answered and Marked for Review, your answer for that question will be considered in the evaluation.



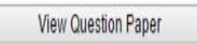
- To mark question to attempt review later.

- A) Combined merit list of eligible candidates will be displayed on M.C.D. website and on the Notice Board of the RVS Nursing School Swami Dayanand Hospital on **10.10.2020 (Saturday)**

- c) In case of two or more candidates obtaining equal marks in the merit list, the merit of such candidates would be determined in the following order of performance.
- i. The candidate, who is older in age, will be higher in merit list.
  - ii. If age is same then the candidate, who has obtained higher marks in aggregate in 10+2 will be placed higher.

#### **CONDITIONS NECESSARY TO CONFIRM ADMISSION:**

- a) If the candidate fails to accept admission and submit original mark sheet and certificate of 10th & 12th, Character Certificate, SC/ST & OBC(Delhi) Certificate, Physically handicapped certificate, EWS certificate (at the time of counselling). Then the seat will be offered to next meritorious candidate
- b) All the admissions are provisional subject to verification of 10+2 certificate from concerned examination board /university / authority.
- c) Appearing in entrance test does not confirm any right to claim

admission if the candidate does not fulfil all eligibility conditions listed under various heads in the prospectus / bulletin of information.

d) Canvassing for admission in any form will entail rejection /cancellation of application form / admission entry to entrance examination hall.

- Duly filled application form
- Four identical passport size photograph of the candidate.

**5. Original certificate will be deposited** and kept by the school of nursing at the time of admission. In any condition photocopies of certificates will not be accepted. **If a candidate does not deposit original certificate or documents or to have them back later, her admission will be cancelled at any stage of admission/ training** .If the certificates are found to be forged, an FIR will be lodged by the school authority against the candidate and training of the candidate will be terminated from the course immediately without prior notice.

6. If the candidate fails to submit above said documents in original at the time of counselling her right

to admission would be forfeited. No relaxation in this regard would be entertained.

7. Admission will be confirmed only after verification of original certificates from C.B.S.E. / Exam Board and medical fitness by medical Board of respective, Swami Dayanand Hospital.

**8. The candidates who have not attended the 1st counselling / previous counselling are not eligible for next round of counselling.**

9. Merely inviting/ appearing for counselling up to specified rank does not guarantee any rights to admission.

10. Caste Certificate should be issued in the name of candidate by competent authorities at the time of applying, if not, the candidate will not be entitled for benefit of reservation.

### **TUITION FEE**

Rs. 10000/- (Rupees Ten thousand only) for 3 years to be deposited at the time of admission. The payment will be taken by Demand draft (detail will be given at the time of admission).

In case a student is unable to clear the GNM Course within 3 year, she would be required to pay Rs. 3000/- per annum additional fee for every additional year of training.

### **BOARDING & LODGING:**

Residency is compulsory for all selected candidates. Free furnished accommodation, free electricity, and water are provided. Membership in the hostel mess is compulsory for the students. They have to pay mess charges according to institutional policies (per month) as amended from time to time in advance..

**BOOKS & STATIONARY:** Each student is required to have her own books and stationary as prescribed by the school from time to time.

### **UNIFORM:**

- ❖ Students must have 4 sets of uniforms, as prescribed by the school:
- ❖ Students are required to wear pink check salwar suit, white coat during their training period. White Gola shoes and white socks.
- ❖ No ornaments or jewellery permitted to be worn with uniform.
- ❖ The prescribed uniform can be changed as per directions.

**LIST OF ARTICLES TO BE BROUGHT BY THE STUDENT AT THE TIME OF HOSTEL JOINING AFTER ADMISSION:**

- Personal items like: Pillow, Bed sheets, Blanket, Quilt, Mattress, Bed Covers, Bucket, Mug, Jug, Lock with two keys, Umbrella, Wrist Watch with seconds hand needle, Adequate personal clothes and towels etc.
- Three sets of photocopy of documents attached with form.
- Three sets of photo graph of parents/ relative to be visited to their wards.
- Blue and Red Pen, Pencil & scale etc.

**HOSTEL RULES & REGULATIONS:**

1. The students are required to abide by the rules and regulation of the school, hostel and hospital, which are enforced time to time.
2. Any act of misconduct and indiscipline will be dealt seriously & the authority has the right to terminate her training without giving any prior notice.
3. The names of the occupants of the rooms will be displayed on the door.
4. In mates should co-operate in the up-keeping of the Nursing Hostel and its good name.
5. Students are prohibited from using electronic gadget (heater, hot plates, radio & Tape Recorder) and Mobile phone.
6. The student should close the taps and switch off electric appliances (lights, fans) before leaving the room.
7. Student should keep their rooms tidy, clean and should take care of furniture and other articles supplied to them for use.
8. Students are not allowed to keep large amount of money and costly articles in their rooms. In case of any loss or theft, authorities are not responsible.
9. Students should sleep in their own rooms. All light should be put off by 10:00 PM.
10. Inmates are not permitted to keep pets.
11. Meals will be served in the Dining Hall only at fixed hours. They should go to mess properly dressed with hair tie. If student is busy in their ward home sister should be informed so that their meals can be pre- served.
12. All the mess charges should be paid before 10<sup>th</sup> every month, otherwise students have to pay Rs. 20/- per day as penalty charges.
13. No crockery can be taken away from Dining Hall. Food and tea is not allowed to be carried away from the Dining Hall.
14. Inmates will be held responsible if they break or cause damage to the crockery or other articles

belonging to the Dining Hall and Hostel.

15. Students are not allowed to occupy any room except one which is allotted to them. If they desire to change rooms in case of any problem, should get permission from the principal through home sister / warden.

16. Students are forbidden to accept any gift in cash or kind from patients or relatives.

17. Student should pay for any purchase made by them and will not be allowed any type of malpractice.

18. Students are required to provide local and permanent address along with phone numbers to the home sister, so that they can contact be contacted in case need arises.

19. **In case of illness** either Hostel or home student should report to the concerned Competent Authority immediately (class teacher and Warden both).

20. Students are not allowed self-medication or consuming harmful drugs. If found so, can be dismissed from training without prior notice.

21. If the student is admitted in the hospital/nurses sick room, the female guardian should be with their ward round the clock.

22. Student can go home alone and come back to hostel with prior undertaking through their parents/guardians.

23. In case of any indiscipline noticed while on sleeping out pass or out going, action as deemed fit will be taken by the principal.

24. Students are allowed to go home on Saturday at 2:00PM and on Gazette Holidays.

25. Students are neither allowed to take any visitor to their rooms nor to visit nursing staff (sister's room).

26. Students are allowed to meet the guardians during the visiting hours i.e. 4:00 PM-6:00PM in the visitor's room.

27. **Students on vacation are not allowed to stay in hostel without the permission of principal.**

On expiry of leave student must be back in hostel in time and report their arrival to the home sister. Unauthorized and unexpected absence will be viewed seriously.

28. While going on leave, duplicate key of the room is to be handed over to home sister, properly labeled with name and room number.

29. No meeting / conference are allowed in the hostel by students

30. School authorities will not allow psychologically unstable students to stay in hostel for the safety of other students till find her suitable to stay in the hostel and parents of such student will make necessary arrangement.

31. No ragging is permitted in the Campus of this hospital. If any student is found violating this instruction and involved in ragging, strict disciplinary action will be initiated against the student as per penalty clause prescribed in the anti-ragging guidelines in their effect. Submission of affidavit on prescribed format (Annex-I & II) is mandatory for each student and their parents / guardians in this regard.

**32. Failure to comply with hostel rules may result in expulsion from hostel and school.**

## **RECREATION:**

In the hostel, indoor & outdoor games shall be provided for students. Recreation, reading materials like news paper, magazines are also provided in the recreation room of the hostel.

## **STUDENT NURSES ASSOCIATION:**

The students have an organization of their own which is affiliated to the Students Nurses Association of India and further affiliated to Trained Nurses Association of India. They are encouraged to arrange their own activities and thus to accept leadership roles. There is a contributory fund which is utilized for sending delegates to conference and to arrange social and cultural activities throughout the year.
